REVIEW AND APPROVAL OF THE DECEMBER MINUTES

REPORTS OF THE OFFICERS

President's Report – Dawn Farina

- a) **TPCBA Ballot**: Dawn announced that the election ballot for TPCBA position was sent to members. Results would be tabulated on January 23 at 4:00 p.m.
- b) **Lincoln** Day Bertha Snell Award: Dawn explained that the Bertha Snell Award is awarded to someone who has overcome obstacles in their lifetime. Dawn encouraged everyone to think about nominees and to get them to her.
- c) **Website:** Dawn, Kit, and Laurie have been working on the new web site which is scheduled to go live at the end of January or in February. Dawn urged board members to send committee photographs.

Vice-President's Report—John Christensen

Moranco & Associates Proposal: John talked briefly about Moranco's proposal. John noted that in 2011 the Board of Trustees voted down Moranco's proposal. Since then, Moranco has worked with the Washington Trial Lawyers and Defense Lawyers. John explained that, similar to our Lincoln Day sponsors, Moranco collects money and then funds things for these bar organizations. Stephanie noted that the amount of the donation seemed to be tied to the premium earned by Moranco. John asked members whether they favored having a Moranco representative come to address the BOT. Steve Merrival expressed his concern that this proposal would essentially make the TPCBA an insurance company. Steve suggested having a member of the BOT meet with Moranco and report back. The BOT then reached a consensus to allow Moranco to come to address the BOT on their proposal at the next meeting.

REPORTS OF THE LIAISONS/COMMITTEES/SECTIONS

Judicial Liaison Superior Court - Judge Frank Cuthbertson

Judge G. Helen Whitener's Swearing In Ceremony: Judge Cuthbertson announced that G. Helen Whitener's Superior Court Judge swearing in ceremony is scheduled for February 5 at 4:00 p.m. Judge Whitener was attending a judicial college in January.

Mental Health Court: Judge Cuthbertson also announced that Superior Court is beginning a felony mental health court and Judge Murphy will be in charge of it.

Firearm in Courthouse: Judge Cuthbertson mentioned that one week ago an attorney entered the courthouse with a concealed weapon in his briefcase. A general discussion followed as to what steps should be taken to address this issue, including revoking the TPCBA courthouse bar identification card of anyone who violates the no firearms policy.

Judge Culpepper announced that Jeannette Lineberry would have her swearing in on Thursday and Pat O'Malley's retirement event was on the same day.

Judicial Liaison Municipal Court – Judge Elizabeth Verhey

Judge Verhey announced that Drew Henke started as the new Tacoma Municipal Judge on January 12.

WSBA BOG Liaison Report – Keith Black

Keith asked members to contact him regarding any legislative bills that are of interest to them. Keith explained that the WSBA's Legislative Committee monitors law related bills.

Young Lawyers Section - Lindsay Camandona

Lindsay reported that the YLs are working with Commissioner Kiesel on finding topics for legal education. Lindsay said the YLs will be publishing a new edition of the TPCBA photo directory this year.
